Mr. Ashwin Gandhi, President of the Association thanked all the members and briefed about various activities of the Association. Following agenda was taken up for discussion in the meeting:

- Minutes of the 4<sup>th</sup> meeting held on 7.11.2011 at Pune were read out and approved in the meeting.
- Mr. Premal / Pinakin Thakkar informed the members that the Association must put all efforts to enroll maximum number of crane owners as its members from all over India. In each State, one or two senior crane owners must be identified, so that they can be made responsible for enrolling maximum number of members.
- List of members of the Association as on 31.03.2012 was distributed to each Committee member and also read out the names in the meeting with amount of contributions received till 31.03.2012.

5. The President applauded this gesture on the part of all the members present. Further, Mr. Premal / Pinakin Thakkar prepared a list of about 50 more members from Pune & Mumbai area with suggestions received from the members present at the meeting from whom corpus fund / membership forms can be collected. Various members were assigned the responsibility of collecting the corpus fund & membership forms as per list attached (Annexure – “A”). The members agreed to use their good offices to collect the corpus fund/forms to strengthen the Association.

6. Members enquired if part time or full time person can be engaged at Mumbai in next 3 – 6 months time to co-ordinate the activities being done from Vadodara.

7. Mr. Gandhi was authorized to go ahead and prepare / finalize the website for the Association, as assigned to the Mumbai agency, as early as possible.

8. The draft of the `Receipt` to be issued by the Association to the members for the payments received was approved by all the members present. It was also approved to treat the subscription/membership amounts received by the Association for period 2012-13 (April 2012 to March 2013).

9. The draft of `Membership Certificate` to be issued to all the members of the Association was approved in the meeting. However, suggestion was received in the meeting to issue Pocket Size Identification Card, like Credit Card (without photograph) to all the members. Mr. Premal / Pinakin Thakkar was given the responsibility to get quotation for printing about 1500 – 200 such cards. Art work will be prepared/approved by Mr. Ashwin Gandhi for printing. However, embossing/printing of such cards will be done at Mumbai / Vadodara, after inserting the Membership Number & name of the member.

10. All the members were requested to meet again on 27.04.2012 at **Renaissance Mumbai (Powai) from 6.00 p.m. to 7.00 p.m.** when large number of crane owners are likely to be available at the venue.

The meeting ended with a vote of thanks to the Chair.
